

### TAB MATCH 3 - TERMS AND CONDITIONS

1. All Entrants (“**Entrants**”) who participate in this TAB Match 3 Competition (the “**Competition**”) are deemed to accept these terms and conditions of entry. Entries that do not comply with these terms and conditions will be deemed invalid and the Racing Industry Transition Agency (“**TAB**”) takes no responsibility for such entries. All times given in this terms and conditions are references to New Zealand Local Time and all references to currency are referring to New Zealand Dollars.
2. The Competition Entry Period opens at 12:01AM on Thursday 01 August 2019 and closes at 11:59PM on Sunday 31 August 2019 (the “**Competition Period**”).
3. To be eligible for entry into this Competition, an Entrant must:
  - Be eighteen (18) years of age or over from the time the Entrant first participates in the Competition during the Competition period; and
  - Hold a TAB account with the TAB during the Competition Period; and
  - Have opted to receive electronic promotional material from the TAB during the promotion period (“**Promo Yes TAB Account**”).
4. The TAB reserves the right to require any Entrant to produce identification to verify his or her age.
5. The TAB Match 3 Competition comprises a series of thirty two (32) Daily Prize Draws (“**Daily Prize Draw**”) – one (1) Daily Prize Draw will take place on each day of the competition period, and one day after the Competition Period ends. The first Daily Prize Draw will take place on Thursday 01 August 2019 and the last Daily Prize Draw will take place on Sunday 01 September 2019.
6. Subject to conditions 7 and 22, to receive an entry into the Daily Prize Draw (“**Daily Prize Draw Entry**”), an Entrant must place at least one (1) bet, of one dollar or more between the hours of 12:01AM and 11:59PM (“**Promotion Bet Period**”) on one of the following bet types:
  - Any Racing Bet
  - Any Sports Bet
  - A Multi bet of 3 legs or more made in accordance with condition 8
  - A “**Daily Bet**” determined by the TAB, as communicated by TAB to the Entrant by email on the relevant day during the Competition Period,

(a “**Promotion Bet Type**”)

through that Entrant’s Promo Yes TAB Account on any single day during the Competition Period (a “**Promotion Bet**”)
7. For the purposes of this Competition, a Multi bet will only constitute a Promotion Bet if it is made in accordance with the requirements of condition 8 and is made up of three (3) or more legs/options (excluding Boxed Multi bets).
8. Bonus Bets placed by an Entrant will not constitute a Promotion Bet.

9. An Entrant will receive one (1) Daily Prize Draw Entry for a Promotion Bet. However, an Entrant will receive a maximum of one (1) Daily Prize Draw Entry for each Promotion Bet Type during the Promotion Bet Period, regardless of whether the Entrant makes multiple Promotion Bets on that Promotion Bet Type. Placing more than one (1) of any of the specified Promotion Bets during any specific Promotion Bet Period will not earn that Entrant any additional Daily Prize Draw Entries in the respective day's Daily Prize Draw.
10. Subject to condition 20, Should an Entrant not place a valid Promotion Bet during the Promotion Bet Period for any particular day during the Competition Period, the Entrant will not receive a Daily Prize Draw Entry for that day.
11. By 10:00AM the following morning after each day within the Competition Period, the Daily Prize Draw will take place. Ten (10) \$50 Bonus Bet prize winners ("**\$50 Bonus Bet Winner**"), twenty (20) \$30 Bonus Bet prize winners ("**\$30 Bonus Bet Winner**"), thirty (30) \$20 Bonus Bet prize winners ("**\$20 Bonus Bet Winner**"), fifty five (55) \$10 Bonus Bet prize winners ("**\$10 Bonus Bet Winner**"), eight hundred (800) \$5 Bonus Bet prize winners ("**\$5 Bonus Bet Winner**") will be randomly drawn from all eligible Entrants that received a Daily Prize Draw Entry (the "**Daily Prize Draw Result**"). The Daily Prize Draw will take place in the presence of a designated TAB representative.
12. There is a total prize pool of \$200,000 in **Bonus Bets** available to be won throughout the Competition Period, broken out into:
  - Three hundred and twenty (320) x \$50 Bonus Bets;
  - Six hundred and forty (640) x \$30 Bonus Bets;
  - Nine hundred and sixty (960) x \$20 Bonus Bets;
  - One thousand seven hundred and sixty (1,760) x \$10 Bonus Bets; and
  - Twenty five thousand six hundred (25,600) x \$5 Bonus Bets,

(the "**Prizes**")
13. Subject to condition 20, by 12:00PM on the day that any Daily Prize Draw has taken place, all Entrants who placed a Promotion bet during the previous days Promotion Bet Period will receive an email from the TAB that contains a website link to the TAB Match 3 website (the "**Prize Draw Website Link**"). The Prize Draw Website Link will be emailed to the email address which the TAB has registered against the Entrant's Promo Yes TAB Account. Entrants are responsible for ensuring their email address is up to date, and that they will have access to that email address.
14. For the avoidance of doubt, the Prize Draw Website Link will be deemed to have been delivered to the Entrant on the day and time that it is distributed to the Entrant's email address by the TAB, as recorded by the email deployment server of the TAB's agent Skinny Marketing.
15. An Entrant must click the Prize Draw Website Link to visit the TAB Match 3 website and click 'Let's Play' at the TAB Match 3 website prior to 11:59PM (the "**Claim Deadline**") on the day on which the Prize Draw Website Link is delivered to the Entrant in order to reveal if the Entrant is a;
  - (a) \$50 Bonus Bet Winner; or
  - (b) \$30 Bonus Bet Winner; or
  - (c) \$20 Bonus Bet Winner; or

- (d) \$10 Bonus Bet Winner; or
- (e) \$5 Bonus Bet Winner; or
- (f) Non-winner,

on that particular day.

16. Subject to condition 17, each eligible Daily Bonus Bet Draw Winner who clicks the Promotion Entry Website Link to visit the TAB Match 3 website and clicks 'Play' at the TAB Match 3 website prior to the Claim Deadline will receive a Daily Bonus Bet Prize (either a \$50, \$30, \$20, \$10 or \$5 Bonus Bet Daily Prize as determined by the Daily Bonus Bet Draw). Following the Daily Bonus Bet Draw Winner claiming their Daily Bonus Bet Prize(s) in accordance with these terms and conditions, the Daily Bonus Bet Prize(s) will be automatically added to the Entrant's Promo Yes TAB Account, which was used to place the original Promotion Bet, on the next business day following the Claim Deadline. 17. An Entrant may win multiple Daily Bonus Bet Prizes as a result of having multiple Daily Bonus Bet Draw Entries determined as a Daily Bonus Bet Draw Winner. In the event that an Entrant receives more than one (1) Daily Bonus Bet Prize, the total value of the Daily Bonus Bet Prizes won from the relevant Daily Bonus Bet Prize Draw will be added together and automatically added to the Entrant's Promo Yes TAB Account, which was used to place the original Promotion Bet. By way of example only, if an Entrant won one (1) \$5 Daily Bet Bonus Prize and two (2) \$10 Daily Bonus Bet Prizes, following a Daily Bonus Bet Draw, then the Entrant would receive a \$25 Bonus Bet.
18. For the avoidance of doubt, Daily Bonus Bet Prize Winners will not be restricted from winning any subsequent day's Daily Bonus Bet Draw.
19. All care will be taken to ensure that the correct Daily Prize Draw Result will be reflected in the Match 3 game illustration when an entrant visits the TAB Match 3 website and clicks 'Play'. Notwithstanding what is displayed on the TAB Match 3 website, Entrants will only be eligible for Prizes that are awarded as a result of the Daily Prize Draw Result. Any entrants that are incorrectly shown a winning result (as a result of a technical error or any other reason) will not be awarded the corresponding Prize.

#### **Introductory Bonus Play Day**

20. For the first Daily Prize Draw (which will take place on Thursday 01 August 2019), all eligible Promo yes TAB account customers will be included in the Daily Prize Draw, and receive a Prize Draw Website Link, regardless of whether they placed a valid Promotion Bet or not on Wednesday 31 July 2019. This will only take place on the opening day of the promotion, to launch TAB Match 3 to all eligible TAB account customers ("**Introductory Bonus Play Day**").

#### **General Terms**

21. The TAB reserves the right, at any time, to verify the validity of any Promotion Bet or Daily Prize Draw Entry and to disqualify any person who submitted a Promotion Bet or Daily Prize Draw that is not in accordance with these terms and conditions, or who tampers with the entry process or attempts to act in a fraudulent or dishonest manner.

22. The following persons are not eligible to enter this Competition or win either a Daily Bonus Bet Prize or a Grand Prize:
- Any “excluded customer” of the TAB (being a customer who has self-excluded from the TAB’s products/premises, as well as any customer who has been excluded by the TAB); and
  - Any customer involved in TAB accounts established for a syndicate, commercial or group use.
23. If this Competition cannot be run as planned for reasons beyond the control of the TAB, the TAB reserves the right in its sole discretion to cancel, terminate, modify or suspend this Competition.
24. The TAB takes no responsibility for any inability to enter, complete, continue or conclude the Competition due to equipment or technical malfunction, Acts of God or otherwise.
25. Except for any liability that cannot be excluded by law, the TAB and any person in connection with this Competition are not liable for any direct, indirect, special or consequential loss or damage whatsoever suffered or personal injury suffered or sustained in connection with:
- participation in this Competition; or
  - the use of any Prize; or
  - the administration of this Competition.
26. Failure by the TAB to enforce any of its rights under these terms and conditions at any stage does not constitute a waiver of those rights.
27. Any personal information provided by an Entrant in participating in this Competition will be held in accordance with the Privacy Act 1993.
28. The TAB will not disclose the personal information provided by Entrants as part of the Competition to any person, organisation, agency or other third party except as provided for by these conditions, under the TAB General Terms and Conditions, Betting Rules or as may otherwise be required by law. Entrants may request access to their personal information or may request that their personal information be removed from the database, or corrected, by contacting the TAB.
